Export Orders

Normal shipping terms are Ex-Works. Depending on destination, export orders may be subject to additional charges for Duty, Value Added Tax (VAT) or Goods and Services Tax (GST), etc. These charges are assumed by the buyer. Shipping Terms

Shipping Method: Shipment is available via UPS, FedEx, DHL, and Postal. You may specify a carrier and manner of shipment, and we will use this carrier when possible.

FOB Point: All shipments are FOB shipping point (50 Intervale Road, Boonton, NJ 07005 US).

Shipping Charges: Prepaid and separately added to the invoice or billed directly to customer's shipping account.

Insurance: Available by carrier at current rates and by specific request when placing your order. Insurance costs are assumed by the buyer.

Title and Ownership: Title and ownership of all merchandise is transferred to consignee upon delivery to a commercial carrier. Acknowledgement of receipt of merchandise in good condition is made by the commercial carrier.

Warranty

All product manufactured by INSTOCK Wireless is guaranteed to be free from defect in material and workmanship, under normal use, for a period of **5 years** from date of invoice. This warranty is limited to repair or replacement of defective components as determined by our inspection and discretion. Please contact us to obtain a **Return Material Authorization (RMA)**. Packaging and all transportation expense is assumed by the customer.

Damaged Goods

Inspect carton upon receipt for visible signs of damage. If carton is received conspicuously damaged, refuse acceptance and/or alert carrier to the condition.

Merchandise Return and/or Exchange

Material will be accepted for return or exchange within 30 days from the date of invoice provided the returned goods are unused, undamaged and in a resalable condition as determined by our inspection. Custom designed product is not eligible for return. Please contact us to obtain a **Return Material Authorization (RMA)**. Packaging and all transportation expense is assumed by the buyer. All returned material is subject to a 15% restocking charge, except for the return of items covered by the standard terms of warranty.
